

The Minutes of the Council of the Village of Luckey

The regular meeting of the Council of the Village of Luckey held on February 7th, at 7:00 p.m. was in the Municipal Building. The following members were present: Councilpersons: Mike McNulty, Alison Okenka, Mike Franklin, Don Brickner, the Mayor, Village Administrator Randy Bielinski, Village Solicitor Corey Speweik, and Fiscal Officer Barb Rizzo. Absent from the meeting was Richard Heilman and Pat Covarrubias

The mayor led the Pledge of Allegiance.

The mayor acknowledged and thanked all of the visitors for coming.

The mayor gave an update on the water and the meeting with the EPA that took place on January 19th. The mayor mentioned that all updates will be available to view on the Village of Luckey website.

The mayor gave the opportunity for each of the visitors to speak.

Sara Brockschmidt mentioned that she wanted to make council aware of the parking problem in front of the post office. The Loving Luckey website showed several comments about parking be limited or having no spaces to be able to get access to be able to pick up mail. This situation has become more difficult due to the heavy traffic in the area for the new businesses. Sara said this was a good thing that Luckey is growing but that the parking needed to be addressed for solutions.

Randy Bielinski responded to Sara and said in the spring, there will be painting of lines for the handicap spaces and they will review the parking situation for possible solutions.

Ordinance Review: none


New business:
