The regular meeting of the Council of the Village of Luckey held on September 17th, 2025 at 7:00 p.m. and was held in the Municipal Building. The final postcards were passed out to all the council persons to see the final production before mailing which will occur mid-October.

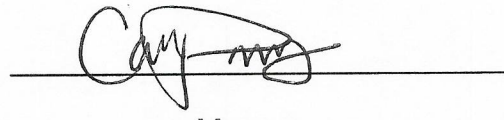
The mayor said that Trick-or-Treat will be held on Thursday, October 30th beginning at 6:00 p.m. and will end at 7:30 p.m.
