

The Minutes of the Council of the
Village of Luckey

The Regular meeting of the Council of the Village of Luckey held on August 2nd at 7:00 p.m. was in the Municipal Building. The following members were present: Councilperson: Lisa Skriba, Mike McNulty, Michael Franklin, Donald Brickner, Richard Heilman, the Village Administrator Randy Bielinski, Village Solicitor, Corey Speweik, Fiscal Officer Barb Rizzo, and Mayor Cory Panning. Absent from the meeting was Pat Covarrubias.

The mayor led the Pledge of Allegiance.

The mayor recognized the visitor, Dawn Stacey. Dawn expressed that she was here to listen and observe. Dawn brought up a concern at the stop sign on the corner of Park and Broadview. Dawn stated that the area has 2 stop signs and children are riding bikes through the area. Dawn expressed her concern and stated that there are a lot of people that go through the traffic sign and she feels that the situation is dangerous and a troublesome spot.

Police Chief, Randy agreed with the concerns that Dawn Stacey brought up and stated he will post something on social media regarding the area to help make the community aware.
